This Order amends the Immigration (Isle of Man) Order 2008 (S.I. 2008/680). It makes amendments to Isle of Man immigration legislation which are equivalent to amendments previously made to UK immigration legislation, thus maintaining the Isle of Man's integrated approach to immigration policy with the United Kingdom.

Isle of Man residents are free to travel to the UK, provided they comply with the terms of any Isle of Man visa they hold. People other than British and EEA citizens typically require Isle of Man immigration permission in order to visit, work or live in the Isle of Man.

### Immigration - Kinley Legal: Isle of Man lawyers

The 2019 Act defines “exit day” as 11.00pm on 31 January 2020 and provided for certain EU law and rights to be retained as Manx law on and after exit day. The 2019 Act also repeals the European Communities (Isle of Man) Act 1973 (“the 1973 Act”) on exit day.

### Isle of Man Legislation - Home

Although the Isle of Man is largely autonomous, the Parliament at Westminster still legislates for the island in respect of some subjects which are of common concern to the Isle of Man and the United Kingdom, such as defence, nationality and immigration. EU law only has direct application to the Isle of Man for very limited purposes.

### Law - Isle of Man

The Isle of Man is not permitted by EU law to discriminate between the citizens of the UK and those of other EU countries, and consequently any British or other European citizen is currently free to migrate to the Island and live there.
