In order to pass the Utah bar exam, you must score at least 270. This equates to 135, based on the MBE's 200-point scale. The scores of the exam sections are weighted as follows: MEE 30%, MPT 20%, and MBE 50%. Utah makes bar exam results available approximately two months after the exam.
