Malaysia is a signatory to UNCSR 1540, and recently passed the Strategic Trade Act 2010 (??TA?? which comes in to force on 1 October 2010. The Ministry of International Trade and Industry (??ITI?? established a Strategic Trade Secretariat on 1 August 2010 to coordinate the implementation of the STA, which aims to prevent illicit trafficking of materials linked to WMD, including electronics, avionics and software through Malaysian territory, and to secure trade against terrorist infiltration.
