If you add emphasis to a direct quotation, place the words “[emphasis added]” in square brackets after the words you have italicized. Research on creativity indicates that “promoting creativity without attending to the subsequent psychological and behavioral changes decreases rather than increases [emphasis added] organizational performance over the long run” (Ng & Yam, 2019, p. 1157).

Use of Italics

When to Italicize - YourDictionary.com
Italicize words presented as words (e.g., the word the). Italicize letters presented as letters (e.g., the letter q). Italicize titles of publications and large works (e.g., The New York Times, Citizen Kane, Pride and Prejudice, What to Expect When You’re Expecting).

Italics (when to italicize) - Grammarist
In addition, you should only italicize the names of individual vehicles. If you’re writing the name of a brand or make of a vehicle (e.g., Ford Escort or Boeing 747), by comparison, you don’t need italics. Italicizing Non-English Words.
